****You must submit the Application for Change of Name to the Circuit Court of the City/County in which you live. **** <u>Must have proof of residency:</u> a utility bill in your name, or current lease/mortgage or voter registration. ****

To file your Child's Name Change you must have the following:

- A. An original completed and notarized original Application for Change of Name.
- B. An original completed Order for Change of Name. The order shall contain no identifying information other than the applicant's former name or names, new name, current address, and date of birth.
- C. \$46.00 Filing Fee The Filing fee may be paid by cash, credit card, check or money order payable to, Clerk of the Circuit Court, 150 St Paul's Boulevard, 7th Floor, Norfolk VA 23510.
- 1. The consent of BOTH parents must be obtained to change a child's name.
- 2. A Copy of Child's Birth certificate.

- 3. Proof of paternity may be applicable.
- 4. If one of the parents does not consent by joining in the Application for Change of Name, the Applicant must place the case on the Court's Docket. The Applicant must serve the non-joining parent in accordance with Virginia Code Section § 8.01-296. The non-joining parent must be served with a copy of the Application for Change of Name, the proposed Order, and the Notice setting the hearing date.
- 5. If the location or identity of one of the parents is unknown, then statement of due diligence must be filed, then an Affidavit and Order of Publication must be submitted. A publication can be done in any Newspaper where the Newspaper has been authorized by this Court to print legal notices and publications in accordance with §8.01-324. An Order of Publication shall be published in a newspaper prescribed by the court pursuant to §8.01-317. The Order must be published for four consecutive weeks. The number of times that the publication is in the newspaper is prescribed by statute. The Court currently utilizes Inside Business and Virginia Pilot (Virginia Media). At time of filing the name change forms, submit the following documentation:
 - Due Diligence Form.
 - Affidavit for Order of Publication.
 - Order of Publication.
 - A copy of the Application Change of Name to be served by Publication.

You may email the docket clerk at <u>civildocket@circuitcourtva.us</u> to schedule a hearing date after the "appear by date" on the Order of Publication. Following the publication, the newspaper will provide you with a "proof of publication" please email that to <u>civil710@circuitcourtva.us</u>. If the couple was married at the time of birth and the mother did not place the father's name on the Birth Certificate (falsifying records) then a Petition and Order must be submitted to the Court. We strongly suggest that you contact an attorney or complete research at the Norfolk Law Library located at 150 St. Paul's Blvd., 1st then to 2nd Floor, Norfolk, VA 23510.
